The CMPA determines membership fees based on your region and type of work (TOW). Select the type of work that most accurately reflects all your professional responsibilities. Fees by TOW code and fee region are listed on the reverse.

Family medicine or General practice (TOW)	
Family medicine or General practice (private office, CLSC, hospital or ward work, walk-in/urgent care clinic, home care, nursing home, or chronic/long-term care facility). Includes assistance at surgery.	
<ul style="list-style-type: none"> <li>If working primarily in geriatric, palliative or physical medicine and rehabilitation, choose code 27.</li> <li>If work is restricted to occupational medicine, choose code 51.</li> <li>If work is restricted to minor cosmetic procedures, choose code 37.</li> </ul>	
<ul style="list-style-type: none"> <li>Excluding anesthesia, obstetrics (labour and delivery), shifts in the emergency department, and surgery.</li> </ul>	<b>35</b>
<ul style="list-style-type: none"> <li>Primary professional work in family medicine including shifts in the emergency department. (If working primarily in the emergency department, choose code 82.)</li> </ul>	<b>73</b>

Postgraduate training (TOW)	
<b>Residents and Fellows — No moonlighting — Includes electives within Canada —</b>	
<b>Residents and Fellows</b> registered in a postgraduate medical education program, <b>international medical graduates</b> registered in a program to obtain a licence for independent practice and <b>clinical fellows</b> and <b>physicians</b> pursuing a structured university affiliated program.	
<ul style="list-style-type: none"> <li>Includes extra resident shifts, but will not include CMPA assistance in medical-legal difficulties arising from independent practice of medicine outside the program.</li> </ul>	<b>12</b>
<b>Residents and Fellows — With moonlighting/ restricted registration — Includes electives within Canada —</b> extracurricular (outside of a residency training program) practice of medicine by residents and fellows registered in a full-time postgraduate medical education program leading to certification with the College of Family Physicians of Canada (CFPC), the Royal College of Physicians and Surgeons of Canada (RCPS) or a provincial or territorial medical regulatory authority (College).	
<ul style="list-style-type: none"> <li>Will generally include eligibility for CMPA assistance in medical-legal difficulties arising from independent practice of medicine outside of the program whether remunerated or not.</li> <li>Residents and fellows who moonlight must hold licensure or registration acceptable to the regulatory authority (College) in the jurisdiction where the moonlighting takes place.</li> <li>Residents and fellows who limit their clinical activities to moonlighting (e.g. locum) for more than two consecutive weeks must change to a practising physician code.</li> </ul>	<b>14</b>

Work abroad (TOW)	
<b>Humanitarian, Teaching/Research</b> — excludes the USA and all other countries where the U.S. legal system is applied. Minimum period 3 months and maximum period 12 months. Members must confirm eligibility for assistance with the CMPA prior to leaving Canada.	<b>8</b>

Specialties (TOW)	
<b>Teaching in Canada</b>	
This code is exclusive to members who maintain <b>only</b> a clinical teaching role within Canada. To qualify for this code, you must not be in practice, make clinical decisions, write prescriptions, or undertake medical administrative work. You may have contact with patients <b>only</b> for the purpose of clinical teaching, but without involvement in patient care.	<b>7</b>
<b>Administrative medicine — Medical executive/advisor/expert —</b>	
no prescriptions, clinical or patient contact. This code will generally include eligibility for CMPA assistance where medical input is utilized but will generally not include eligibility for CMPA assistance in matters related to non-medical acts performed in administrative roles, such as human resource matters or contractual issues.	<b>20</b>

<i>* This code is not appropriate for specialists or family physicians who also have a general practice. This is also not appropriate for physicians eligible for Resident and Fellows code 12 or 14.</i>
