

## 10 things to know about international medical graduates (IMGs)

1

IMGs are physicians who completed medical school outside of Canada/USA.



This includes Canadians/Americans who went abroad for medical school, then returned to Canada/USA for residency.

Like other organizations, CMPA often uses this term in relation to information and resources intended for IMGs who are new to practice in Canada.


Physicians who complete medical school in Canada/USA are referred to as "CAMGs" (Canadian and American medical graduates).

As of 2023, 28% of CMPA members are IMGs – and that number is increasing.

In fact, IMGs are one of the fastest-growing groups in CMPA's membership.

IMGs are healthcare leaders, frontline providers, and academics.

IMGs hold positions across the breadth of the healthcare system. They include family physicians and specialists, and they practice in all clinical settings – from remote rural communities to large urban hospitals.

In a 2024 CMPA survey, IMGs and CAMGs expressed the same top 5 challenges to their practice:



## Some of these challenges include:



Lack of social support



Adjustments during the immigration process



Encountering discrimination



Less choice in location or specialty



Lack of clarity regarding the licensure process



IMGs do not have a higher rate of being named in civil-legal cases.



We compared the medico-legal case rates and case outcomes of IMGs and CAMGs.

After controlling for variables such as province of practice, years in practice in Canada, age, gender, geography, type of practice, and other factors, we found no difference between IMGs and CAMGs in civil-legal case rates and case outcomes.

## **Sources**

CMPA 2024 General Membership Survey; CMPA interviews with 40 IMGs across Canada (from August to November 2024); analysis of CMPA advice calls occurring between 2019 and 2023; multilevel multivariate statistical analysis of medico-legal case data; CMPA literature review on the challenges faced by IMGs.

- Based on responses to the question "What are the top three challenges you face as a practicing physician today?" in the CMPA General Membership Survey in 2024 (total respondents = 8,636; total responses to this question = 6,200). Responses are arranged in descending order according to frequency of mention, which was the same between IMGs and CAMGs. Based on qualitative analysis without statistical significance.
- 2. Based on analysis performed on de-identified, aggregate data on 5,764 advice calls coded in this time period.
- Based on literature review on challenges facing IMGs and a qualitative research study including interviews with 40 licensed IMGs across Canada.
